

FULL MEMBERSHIP APPLICATION

Thank you for your interest in Full Membership of the CCE. The purpose of this form is to determine if your application meets the BASIC CRITERIA FOR FULL MEMBERSHIP as outlined on the CCE website (www.cceditors.ca). If you meet these criteria, your application will be considered to have passed Administrative Review and your application materials will be forwarded to a jury of 7 Full Members of the CCE, who will determine if you have demonstrated the qualities of Full Membership as outlined on the CCE website here.

Juries will meet the CCE's standards for equity and inclusion. They will have at least one Full Member in your field of editing (ie, drama, documentary, animation, etc.), and all decisions will be unanimous. Names of jury members will not be revealed to the applicants. If your application is not successful, you will be provided with reasons for the decision and guidance on how you can ensure a successful application in the future. You may then reapply as soon as you feel you have addressed the jury's concerns.

Jury decisions will generally be made within 2-3 months of the application deadline, and you will be notified by the CCE board immediately following the decision. If you have any questions regarding procedures, please contact our Operations Manager at info@cceditors.ca.

LETTERS OF RECOMMENDATION

Two (2) letters of recommendation are required. Letters should be submitted along with this package via upload to the <u>Full Member application portal</u>.

The first letter must be from an <u>active Full Member of the CCE</u> who is familiar with the applicant's full body of work, and has seen the work samples the applicant is submitting with their application. The letter must detail how these submitted works represent the applicant's full body of work and demonstrate their eligibility for full membership.

The second letter must be from an <u>industry professional</u> who has observed the applicant in a professional context, but does not work in post production (for example, a producer or director). For editors who frequently work in teams, the industry professional's letter should reflect their contributions to the team.

You may submit as many samples as you wish, in any genre or length that you wish. At least two of the samples must be complete programs of industry-recognized significance (for example a feature or one hour long television program). You may also submit a maximum of three clips of up to sixty (60) minutes in total duration. The cumulative length of the programs must be greater than 2 hours but less than 5 hours. Short films should not normally make up the majority of the content. You must have a full editing credit on every sample (for animation applicants, Leica or Animatic Editor credits will be acceptable).
